#### **Explanatory Notes to the Notice of Annual General Meeting**

#### **Resolution 1: Reports and Financial Statements**

The Directors are required by law to present to the meeting the audited accounts and the reports of the Directors and the auditors contained in the Annual Report and Financial Statements.

#### Resolution 2: Re-election of Directors

Under the Company's Articles of Association, one-third of the Directors shall retire at each Annual General Meeting. Retiring Directors are eligible to seek re-election by shareholders if they so wish. Andrew Church retires by rotation and, in accordance with the Articles of Association and being eligible, offers himself for reelection. Biographical details of the Directors are given in the Investor Relations page of the Company's website (www.servoca.com) and are set out in the Annual Report on page 7.

#### **Resolution 3: Re-appointment of auditors**

At every general meeting at which accounts are laid before the Company, the Company is required to appoint auditors to hold office until the end of the next such meeting. Baker Tilly UK Audit LLP have indicated that they are willing to continue in office as the Company's auditors for another year. Accordingly, this resolution proposes their re-appointment and, in accordance with standard practice, gives authority to the Directors to determine their remuneration.

#### **Resolution 4: Authority to allot shares**

This authority generally authorises the Directors for the purposes of section 551 of the 2006 Act to allot Relevant Securities up to the stated aggregate nominal amount of ordinary share capital of the Company. This authority, if passed, is in place for a maximum of 15 months from the date of the AGM unless renewed, varied or revoked by the Company prior to or on that date.

#### Resolution 5: Disapplication of pre-emption rights

If equity securities are to be allotted for cash, section 570 of the 2006 Act requires that those equity securities are offered first to existing shareholders in proportion to the number held by them at the time of the offer and otherwise in compliance with the technical requirements of that Act. This resolution, if passed, will allow the Directors to allot shares up to the specified nominal amount for cash without the need to first offer them to the existing shareholders in accordance with that Act.

#### Resolution 6: Authority for the Company to purchase its own shares

The Companies Act 2006 permits companies to make limited market purchases of their own shares subject to shareholder authority. This is a useful mechanism for dealing with limited numbers of shares by the Board if and when required by the Company. The Directors consider it desirable and in the Company's interests for shareholders to grant to the Company authority to exercise this power, within certain specified limits. This resolution would be limited to 12,557,595 ordinary shares, representing 10% of the issued share capital of the Company as at the end of the 2014 financial year. The Directors would exercise this authority only after considering the effects on earnings per share and the benefits for shareholders generally. Any buy back would be by market purchases through the London Stock Exchange. Any shares so purchased would be either held as treasury shares or cancelled. The Company has purchased a total of 577,816 ordinary shares and these are held in Treasury. This authority will expire (unless previously renewed or revoked by the Company in general meeting) at the conclusion of the next AGM of the Company.
